The YWCA is dedicated to eliminating racism, empowering women and promoting peace, justice, freedom and dignity for all The YWCA reaches over 12,420 individuals a year It provides needed, mission-focused services to build women's economic equity, empower women and girls, impact their families and build cross cultural competencies in the greater Mankato area The YWCA of Mankato is a non-profit, charitable organization and community resource, 447 volunteers contributed 10,459 hours of service worth \$254,258 at \$24.31 per hour (the MN rate for volunteer compensation) Affiliations the YWCA Mankato is a local association that is affiliated with the YWCA of the USA The YWCA Mankato also serves as an affiliate council of girls on the run international

Programming for women the Elizabeth Kearney women's leadership program is a gender specific program designed to strengthen and enhance the leadership of women in their workplaces and the community The program takes a cohort of women through ten months of facilitated leadership training led by community leaders Each participant creates an individual leadership plan that focuses on their individual leadership goals The program serves 42 women in 2016 Since its inception, the program has focused on five main themes Skill development, redefining power, balance, ethical leadership and reflection The impact of the program on participants is transformative Through monthly assessments, observation and focus groups, the participants identified several impacts that seemed particularly valuable to them The YWCA also offers an annual women's leadership conference as an opportunity for women to learn and build new skills and network with other area professionals The women's leadership conference was attended by over 320 women in 2016

Programming for New American Families Walking in two worlds (W2W) is a program that helps immigrant women and their families who are new to the greater Mankato community In addition to promoting strong family and cultural connections, this program focuses on empowerment and self-sufficiency The goal of hte program is to bring the gifts and talents of immigrant women to the community in a mutually beneficial way Forty-eight women and their families were impacted by this program The Ready to Learn program (R2L) provides early childhood education and tools for kindergarten readiness to children ages birth to 5 within immigrant and refugee households In 2016, the R2L program served 77 children from 31 different families Families do not pay any program fees to participate in W2W or R2L

Programming for girls Girls on the Run serves girls in grades 3-6 while Heart and Sole serves girls in grades 6-8 The goal of these two programs is to inspire girls to be joyful, healthy and confident In 2016, the YWCA served over 248 girls through these two programs Mankato and surrounding rural communities, with 29% receiving a full or partial scholarship to participate Girls Inc serves girls in grades 6-8 with the intention to inspire girls to be strong, smart and bold Ten girls were served through Girls Inc in 2016, and 20% of then received full scholarships to participate SURGE is a leadership program for girls in grades 9-12 andis designed to help girls understand their own ability to control their future through use of their strengths, positive thinking, goal-setting and planning In 2016, 47 girls participated in the program and 100% of participants received a full scholarship for participation










Racial Justice Programming Cultural competency trainings address the invisible and subtle differences between cultures and helps provide cross-cultural understanding These trainings focus on identifying stereotypes, differentiating between bias/discrimination/racism, discussing the difference between immigrants and refugees, and heightening awareness of cultural differences In 2016, 336 community members were served through ten training sessions It's Time to Talk is a trademarked racial dialogue facilitation process that involves trained facilitators leading small dialogue circles about race and racial justice (It's Time to Talk is trademarked by YWCA Minneapolis) Participants exchange idease through a series of questions designed to garner authentic introspection and discussion within a constructive and non-threatening environment It's Time to Talk workshops typical end with a "what's next?" discussion or handout to provide guidance on how participants can continue to move forward A total of 200 community members were served through five workshops in 2016
