Families received an array of assistance from receiving material goods to being referred to essential basic needs such as food assistance, health services, legal services, public benefits and housing assistance. Some families in need were eligible for financial assistance from YWCA Mankato. The Ready to Learn program (R2L) provides early childhood education and tools for kindergarten readiness to children ages birth to five within immigrant and refugee households. In 2017, the YWCA served 111 children from 76 different families. Families do not pay any program fees to participate in W2W or R2L.

Programming for girls Girls on the Run serves girls in grades 3-6 while Heart & Sole serves girls in grades 6-8 The goal of these two programs is to inspire girls to be joyful, healthy and confident In 2017, the YWCA served 296 girls through these two programs in Mankato and surrounding rural communities 24% of program participants received a full or partial scholarship to be in the program Surge is a leadership program for grades 9-12 and is designed to help girls understand their own ability to control their future through their strengths, positive thinking, goal-setting and planning Forty two girls participated in the program in 2017 and 100% of Surge participants received full scholarships to participate in the program GEARS, Girls Empowered and Riding Strong, is a new program that was piloted in the summer of 2017 The program for girls in 6-8 grade introduces participants to all types of cycling teaching girls technical riding skills, mechanical skills for bike maintenance, safety and problem solving skills Woven into the program are empowering and motivating activities to build self-esteem and develop a strong sense of team, where every girl counts The pilot camp served 5 girls and 40% of GEARS participants received a full or partial scholarship to be in the program
