Racial Justice Programming In 2018, 200 community members and civic leaders participated in a Stand Against Racism event where attendees took part in educational exercises, walked through exhibits and attended a program all centered around racial justice advocacy A new workshop, Race IQ, was offered to the public with 400 participants completing the highly interactive training session This year, It's Time to Talk workshops served a total of 565 people, comprised of rural community residents, educators from various school districts, and university students Through a commitment to host the annual It's Time to Talk (forums on race event utilizing facilitators exclusively from the local community), the racial justice programming was able to successfully train an additional 45 people, bringing the number of trained facilitators to more than 100 individuals In it's fourth year, It's Time to Talk Forums on Race event hosted over 400 community members As our nation, state, and local community continue to engage the challenge of racial equity, The YWCA Mankato remains an active participant in this vital work
