### **Form 990, Part III, Line 4a:**

Our YMCA is committed to nurturing the potential of every child and teen, as well as our adults. Membership and program scholarships allow participants to join the YMCA on a scale prorated to their ability to pay, free from any possible social stigma from low income. Based on the federal free lunch program, participants may pay as little as 40% of the normal costs for membership and/or program participation. During 2017, our YMCA provided 913 individual or family units with scholarshiped memberships and subsidized the membership fees for 371 St. Cloud Technical and Community College students and nontraditional students, amounting to \$337,966 of financial assistance for memberships alone. The YMCA also provided scholarships for swim lessons, swim team, youth sports, summer and vacation camp, home school fitness program participants and child care in the amount of \$22,716. We continue to provide free memberships for OIF/OEF families while the service person is deployed, and six months of additional free membership for the veteran and family upon the veteran's return. In 2017, this assistance amounted to \$268 and provides full facility and program participation for the veteran and their families. All our members, including those on scholarships, also receive discounted program rates, usually \$20 per program, which is another way we assist those who may not have been able to participate.

---

### **Form 990, Part III, Line 4b:**

The Y is committed to improving America's health and well-being, community by community. The St. Cloud Area Family YMCA works in partnership with many community non-profits and schools by providing day passes for their participants/members to the YMCA facility. Their participation in YMCA programs and facilities promotes social interaction, overall health, builds self-esteem and develops social networking relationships. Some of these collaborations include District 742 Schools, Boys and Girls Clubs, Place of Hope, Journey Home, Northway Group Home, Focus 12, Anna Marie's, Big Brothers/Big Sisters, 180 degrees, St. Cloud Children's Home, The Youth House, Salvation Army and various Preschool, Head Start and Early Childhood programs. We issued \$50,355 of community outreach scholarships, which provides free access to families in transition homes such as Place of Hope and Anna Marie's, and over \$254,500 of community discounts to ensure our programs are accessible, affordable and open to all faiths, backgrounds, abilities and income levels.

---

**Form 990, Part III, Line 4c:**

Our YMCA believes in giving back and supporting our neighbors. One of our community's critical social needs is met with our Supervised Visitation and Exchange program, which provides families who are court ordered to have supervised visitations with a positive, healthy environment in which to interact, offering them a place where family vulnerability is reduced. The YMCA is a safe environment for these exchanges/visits and offers more than a courthouse or attorney's office. Fractured families may have court ordered visitations to ensure the best experience for any child and family member involved. Non-custodial parents (or extended family members) are allowed to visit with their children in a neutral, controlled condition for a set period of time promoting positive interactions through health and wellness for youth development, for healthy living and for social responsibility. We serve court-ordered cases from counties throughout the state as well as many private cases. All cases are supervised by social workers. We provide financial assistance to these families if they cannot afford the services of social workers and the cost of the supervision required for the visits. Sixty-two percent of all participants in court-ordered private visitations receive financial assistance. During 2017, 1,602 visits and 395 exchanges were provided. Supervised Visits were subsidized by the YMCA in the amount of \$15,093 in 2017.
