OF MN DEPARTMENT OF HUMAN SERVICES OUR KAREN LIAISON SERVED HUNDREDS OF LOCAL KAREN FAMILIES, ENSURING THEY HAD THE PROPER SUPPORTS (EDUCATION, HOUSING, HEALTHCARE, DRIVER'S LICENSE, ETC ) TO FIND STABILITY AND MAINTAIN EMPLOYMENT IN FREEBORN COUNTY WE CONTINUE TO ENCOURAGE COLLABORATION, WHICH IS DEFINED AS A MUTUALLY BENEFICIAL AND WELL-DEFINED RELATIONSHIP ENTERED INTO BY TWO OR MORE ORGANIZATIONS TO ACHIEVE RESULTS THEY ARE MORE LIKELY TO ACHIEVE TOGETHER THAN ALONE THIS IS NOT AN EASY TASK, AS TRANSITIONS OF LEADERSHIP HAVE CONTINUED TO OCCUR IN OUR COMMUNITY HOWEVER, WE HAVE RECOGNIZED MORE ENGAGEMENT WITH PROVIDERS AND COMMUNITY MEMBERS IN THE PAST YEAR THAN EVER BEFORE-LIKELY BECAUSE OF ALL OF THE TRANSITIONS AND CHALLENGES WE CAN'T DO WHAT WE'VE ALWAYS DONE AND EXPECT CONDITIONS TO IMPROVE OUR UNITED WAY ASKS QUESTIONS THAT ARE NOT COMFORTABLE WE CONTINUE TO ASK IF WE ARE SUSTAINABLE AS A COMMUNITY AND WHAT WE ARE DOING TO ADDRESS THE UNDERLYING CAUSES OF POVERTY-AS WELL AS BARRIERS FOR SUCCESS SUCH AS AFFORDABLE CHILDCARE, TRANSPORTATION AND HOUSING, THAT WE MUST RESOLVE AS A COMMUNITY IF WE HOPE TO CONTINUE WE CONTINUED THE JOURNEY WITH OUR SHARED DATABASE SYSTEM, MPOWER, AND FOUND MORE SUPPORT THROUGH COUNTY LEADERSHIP IN 2017 WE ARE ENROLLING ADDITIONAL PARTNERS THROUGH THE COUNTY THIS YEAR AND WILL CONTINUE TO EXPAND AS THERE IS INTEREST WE ARE PUSHING TO ASSESS DATA TO UNDERSTAND HOW WE MAY ADDRESS LOCAL ISSUES, SINCE THERE ARE MANY VARIABLES THAT CAUSE WORKPLACE TURNOVER, FOR EXAMPLE THE ACTIONS WE TAKE NOW WILL INFLUENCE OUR SUCCESS IN THE NEXT DECADE IT IS IMPORTANT THAT WE ARE ALL ON THE SAME PAGE AND ARE FOCUSED WITH OUR EFFORTS SO WE MAY ACTUALLY FIND RESOLUTION TO DETERMINE EFFECTIVE PROGRAM FUNDING, COMMUNITY VOLUNTEERS ARE ENGAGED IN THE COMMUNITY INVESTMENT COMMITTEE TO REVIEW PROGRAM REQUESTS THEY VISIT AGENCY SITES TO REVIEW SERVICES GIVEN TO COMMUNITY MEMBERS, ALONG WITH A SEPARATE FINANCIAL INTERVIEW PROCESS A
