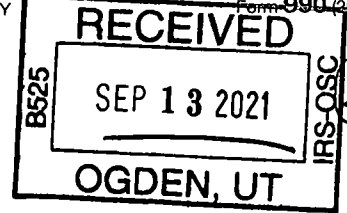

In 2017, NRRC's special projects included: *recording the oral histories of long term Homewood residents *recording the oral histories of long term Willard Hay and Near North Residents *training residents on financial literacy *re-imagining Plymouth Avenue as corridor where children and families thrive *increasing resident participation in Organics Recycling *increasing resident participation in water saving techniques with an emphasis on rain barrels *partnering with Mid Minnesota Legal Aid and Stinson Leonard Street to provide free legal services for NRRC residents facing housing issues *the beginning of the renovation of 1303 Golden Valley road into our new office headquarters *the administration of emergency, senior, and rehab loans along with first time home buyers down payment assistance.
