**1** Briefly describe the organization's mission or most significant activities:  
 The scope of our primary medical services is focused on maintaining access to comprehensive primary and preventative healthcare in order to improve the health status of underserved and vulnerable populations. The primary service area is North and Northeast Minneapolis with NW Hennepin County and Southern Anoka County as secondary service areas. The target population includes low-income people, both uninsured and those on Medicaid. Services are provided at three freestanding clinics: Fremont Clinic in North Minneapolis, Central Avenue Clinic and Sheridan Women & Children's Clinic in Northeast Minneapolis. On-site services include primary care, prevention, outreach, Ob/GYN, chronic disease, interpreting, and assistance with health care plan enrollment. We provide referrals and care coordination for dental, mental health and substance abuse, hospital and specialty services through partnerships with other community organizations.
