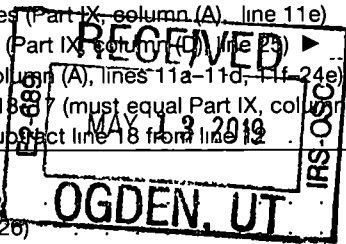

Kinship's youth mentoring program serves to fill a void that many youth have in lacking positive adult role models, especially for those not living with both parents. By working to fill this void, Kinship fosters friendship, social growth & interaction, while at the same time opening doors that our youth may not be able to do for whatever reason. We offer group mentoring activities each month like canoeing, baking, firearms safety, ballgames, crafts & fishing - all of which foster positive youth / adult interaction.

Kinship provides mentoring services to youth (age 6-18) who primarily live in homes w/o both of their parents. This includes single parent homes and also foster, guardian and step-parent situations. These services focus on 1:1 matches and also through group mentoring activities. In 2018 Kinship served 63 youth total (including 7 who were in the nine-night firearms safety program only). We recruited 12 new youth for our mentoring program. 10 new matches were made and 34 total matches were served during 2018.  
Kinship hosted 12 activities during 2018. On average 16 youth and 10 adults attended each activity. Kinship group mentoring activities are a balance of fun, education and community service. At the heart of it, they are an opportunity to foster positive relationships between Kinship's youth and adults.
