REAL ESTATE DEVELOPMENTPRG DEVELOPS AFFORDABLE SINGLE-FAMILY AND MULTI-FAMILY HOUSING IN RESPONSE TO REQUESTS FROM NEIGHBORHOODS, COMMUNITY ORGANIZATIONS, AND SOCIAL SERVICE PROVIDERS. INSTEAD OF TAKING A ONE-SIZE-FITS-ALL APPROACH, WE PLACE A PRIORITY ON SENSITIVITY TO WHAT OUR PARTNER GROUPS WANT AND NEED, AND WE ENGAGE WITH THE COMMUNITY THROUGHOUT THE DEVELOPMENT PROCESS. HISTORICALLY, THIS HAS MEANT CREATING SINGLE-FAMILY HOMES FOR OWNERSHIP AS WELL AS A RANGE OF TYPES OF MULTI-FAMILY AND SUPPORTIVE HOUSING. IN 2016, WE CONTINUED TO ALLOT THE MAJORITY OF OUR DEVELOPMENT CAPACITY TO REHABBING SINGLE-FAMILY, FORECLOSED HOMES AND CONSTRUCTING NEW SINGLE-FAMILY HOMES. SINGLE FAMILY DEVELOPMENTPRG WORKS AT THE REQUEST OF COMMUNITY GROUPS IN THE CORE NEIGHBORHOODS OF MINNEAPOLIS WHICH WERE SEVERELY IMPACTED BY THE FORECLOSURE CRISIS AND DISINVESTMENT. IN 2016 PRG ACQUIRED 6 LENDER- OR CITY-OWNED SINGLE-FAMILY HOMES IN NEED OF SIGNIFICANT REHABILITATION. TWO CITY-OWNED VACANT LOTS WERE ACQUIRED FOR NEW CONSTRUCTION, CONTINUING OUR LONGSTANDING PARTNERSHIP WITH THE PHILLIPS NEIGHBORHOODS OF SOUTH MINNEAPOLIS. OVER THE COURSE OF THE YEAR, WE SOLD 10 HOMES TO LOW- AND MODERATE-INCOME HOMEBUYERS, THE MAJORITY OF WHICH WERE FIRST-TIME HOMEBUYERS AND 90% WERE HOUSEHOLDS OF COLOR. IN 2016, 100% OF PRG'S CONSTRUCTION CONTRACTS WERE AWARDED TO BUSINESSES OWNED AND OPERATED BY PEOPLE OF COLOR OR WOMEN. MULTIFAMILYALL 42 LARGE-FAMILY APARTMENTS THE GREENWAY HEIGHTS AFFORDABLE HOUSING APARTMENT BUILDING IN THE PHILLIPS NEIGHBORHOOD ARE FULLY LEASED UP. THE UNITS ARE AVAILABLE TO HOUSEHOLDS EARNING LESS THAN 50% OF THE AREA MEDIAN INCOME. ALL 46 UNITS AT SPIRIT ON LAKE REMAIN FULLY LEASED TO HOUSEHOLDS EARNING LESS THAN 50% OF THE AREA MEDIAN, INCLUDING FIVE PROJECT-BASE SECTION 8 UNITS FOR FORMERLY THE FORMERLY HOMELESS

HOMEBUYER EDUCATION/COUNSELING AND FINANCIAL COACHINGHOMEBUYING EDUCATION AND COUNSELING SERVICES ARE AVAILABLE TO ALL CLIENTS SEEKING INDEPENDENT, CONFIDENTIAL ASSISTANCE AND INFORMATION, HOWEVER, WE PLACE A HIGH PRIORITY ON MARKETING OUR SERVICES TO FIRST-TIME HOMEBUYERS AND MEMBERS OF UNDERSERVED GROUPS. WE ATTEND COMMUNITY EVENTS AND PARTNER WITH A VARIETY OF COMMUNITY ORGANIZATIONS IN ORDER TO INCREASE OUR IMPACT. IN 2016, PRG OFFERED 16 FIRST-TIME HOMEBUYER WORKSHOPS, SERVING 360 HOUSEHOLDS (61% OF ATTENDEES WERE HOUSEHOLDS OF COLOR). PRG'S PRE-PURCHASE ADVISORS AND FINANCIAL COACHES WORKED WITH 204 FAMILIES DURING THE YEAR (65% OF CLIENTS WERE HOUSEHOLDS OF COLOR). OF HOUSEHOLDS OF COLOR PARTICIPATING IN OUR PREPURCHASE SERVICES, 52% GO ON TO BUY A HOME WITHIN 3 YEARS AT A RATE OF APPROXIMATELY 100 PER YEAR. FORECLOSURE COUNSELINGPRG PROVIDED 50 FAMILIES WITH FREE, ONE-ON-ONE FORECLOSURE PREVENTION ASSISTANCE. OF THOSE WHOSE CASES WERE RESOLVED IN 2016, 73% OF CLIENTS AVOIDED FORECLOSURE AS A RESULT OF OUR TARGETED OUTREACH AND OUR LONG-TERM RELATIONSHIPS WITH COMMUNITY ORGANIZATIONS, A LARGE PERCENTAGE OF THOSE WE SERVE ARE MEMBERS OF UNDERSERVED GROUPS - 66% HAVE INCOMES UNDER 80% OF THE MEDIAN - 44% HAVE INCOMES UNDER 50% OF THE MEDIAN - 42% ARE HOUSEHOLDS OF COLOR
