THE MEN'S PROGRAM ASSISTS MEN IN IDENTIFYING THEIR ABUSIVE BEHAVIOR AND PRACTICING NEW, HEALTHY WAYS TO HANDLE CONFLICT AND PARTICIPATE IN EQUAL RELATIONSHIPS. THE WOMEN'S PROGRAM ASSISTS VICTIMS IN DEVELOPING SELF-CARE AND PROTECTION STRATEGIES, AND ACHIEVE SELF-SUFFICIENCY. WOMEN OVERCOME THE TRAUMA ASSOCIATED WITH ABUSE. THE YOUTH PROGRAM USES GROUP AND INDIVIDUAL THERAPY TO HEAL CHILDREN WHO HAVE BEEN AFFECTED BY ABUSE IN ORDER TO STOP THE CYCLE OF INTERGENERATIONAL DOMESTIC ABUSE. CHILDREN LEARN THAT ABUSE IS NOT THEIR FAULT, AND THEY ARE NOT ALONE. DAP SERVED OVER 550 PEOPLE IN ITS THERAPY PROGRAMS DURING THE YEAR.
