THE WOMEN'S PROGRAM ASSISTS VICTIMS IN DEVELOPING SELF-CARE AND PROTECTION STRATEGIES, AND ACHIEVE SELF-SUFFICIENCY. WOMEN OVERCOME THE TRAUMA ASSOCIATED WITH ABUSE.
