Therapy DAP offers free or sliding-scale services for each member of the family affected by domestic abuse. The men's program assists men in identifying their abusive behavior and practicing new, healthy ways to handle conflict and participate in equal relationships. Of the men who complete the men's program, over 90% do not reoffend. The women's program assists victims in developing self-care and protection strategies and achieve self-sufficiency. Women overcome the trauma associated with abuse. The youth program uses group and individual therapy to heal children, new-born through age 18, who have been affected by abuse in order to stop the cycle of intergenerational domestic abuse. Children learn that abuse is not their fault, and they are not alone. DAP served over 500 people in its therapy programs during the year.

*Advocacy* Advocates provide free, immediate assistance for victims and their families in times of crisis. They offer essential information about shelter, community resources, intervention services, and legal recourse. Advocates follow up with all victims of domestic violence identified by Minneapolis Police each day. They are also present in criminal court hearings to offer support and information to victims of domestic abuse. Advocacy program seeks to be accessible and available to provide crisis intervention services to all domestic abuse victims in need in the community. 96% of women and youth clients discuss a safety plan with an advocate or therapist. Safety plans are a key protective factor for avoiding abuse in the future. DAP served over 1,800 people in its advocacy programs during the year.

Case Management Case managers are part of an interdisciplinary treatment team, working with therapists and advocates at DAP to surround the client with comprehensive services to help them end the violence in their lives and have healthy, fulfilling relationships. Case management services support the safety and stabilization needs of DAP clients. Families affected by domestic violence often do not have access to resources to support their basic needs. This means that clients struggle to find safety and to heal from the effects of the fighting in the family because they are worried about food, shelter, clothing, and their physical and emotional safety. Often the violence itself means that they are ineligible for certain resources, or the financial abuse has rendered them at the mercy of a difficult-to-navigate social service system.
