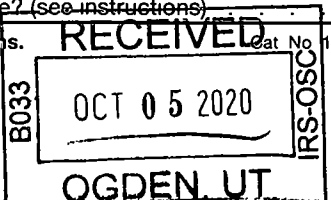

The Displaced Homemaker Grants provide pre-employment and peer counseling services to displaced homemakers who live in south central Minnesota. Services include workshops, individual peer counseling, testing and assessments, advocacy, resources and referrals, and direct client assistance as appropriate. LWPC served 60 newly enrolled and 62 previously enrolled displaced homemakers in this past fiscal year.

United Ways and foundation grants provide pre-employment and peer counseling services to women in transition who live in south central Minnesota. Services include workshops, individual peer counseling, testing and assessments, advocacy and resources and referrals. Target populations are low income women, abuse survivors, single parents, and women moving off of public assistance to self-sufficiency. This past fiscal year, LWPC served 27 newly enrolled and 37 previously enrolled women in transition. This program also served 90 clients through collaborative programming that were not specifically enrolled in this program.

Southern Minnesota Recovery Connection (EIN 45-3630765) went out of business after July 31, 2014. They continued to look for funding in order to reopen, but by the end of their fiscal year on June 30, 2015, they had not found additional funding sources and closed for good. They had received dedicated funding for a trip for their clients to go to the capital to talk to legislators about their concerns, but bills for that trip were never submitted to SMRC by the parties involved. SMRC asked LWPC to take these funds and pay any bills if they were ever submitted. If no bills were submitted within a two year time period, LWPC was encouraged to use the funds in a similar way/training. This fiscal year none of the remaining funds were spent because of COVID-19 by the Blue Earth County Drug Task Force. LWPC is still holding the remaining funds open for yet an additional year.

The funds provided to Displaced Homemakers and Women in Transition fall into what LWPC considers "specific assistance". The allocation and monitoring of those funds comply with the requirements of the various grantors. "Client Transportation" was bus tokens given to two clients (\$50), taxi fees for one client (\$159), cash mileage reimbursements given to four clients (\$102) and script cards given to 60 clients (\$950). "Snack" are refreshments provided to class participants during the longer "Spirited Journeys" trainings (\$161). "Books" were materials used during group meetings (\$122). "Script cards for Clothes" were given to 48 clients to buy interview clothes or specific items needed for their job (\$5,080). "Client Assistance" has many components. Five clients received rental assistance or application fees for housing (\$1,102); Three clients received help with utility bills (\$231); Eight clients received help with car repairs (\$2,533). Two clients received help with car insurance (\$277). One client received help with a car payment (\$387); Eleven clients received used computers and/or internet (\$1,254). Eight clients received help with tuition, books or driver license fees (\$553); and Eight clients received enhanced empowerment training (\$730). Please note that an additional (\$4) was spent in this category to replace two defective containers from another donor.
