MOST FAMILIES WHO USE THE NURSERY ARE EXPERIENCING EXTREME CIRCUMSTANCES SUCH AS TRAUMA, MATERNAL DEPRESSION, DOMESTIC VIOLENCE, HOMELESSNESS, MEDICAL OR MENTAL HEALTH CONCERNS, AND ISOLATION PRIMARILY RESULTING FROM EXTREME POVERTY. THESE SITUATIONS OFTEN PLACE CHILDREN AT A MUCH GREATER RISK OF ABUSE AND NEGLECT. THE NURSERY RESPONDED TO 3,808 CALLS THROUGH THE CRISIS HOTLINE. THE NURSERY'S QUALITY OVERNIGHT RESIDENTIAL CARE PROVIDED 5,746 DAYS/NIGHTS OF CARE TO 2,206 CHILDREN IN 1,283 FAMILIES LAST YEAR. APPROXIMATELY 65% OF THOSE WE SERVE ARE FEMALE, 93% ARE PEOPLE OF COLOR OR THOSE IDENTIFYING AS NATIVE OR HISPANIC, AND 90% OF FAMILIES HAVE ANNUAL INCOMES OF \$10,000 OR LESS. IN FY19, 99% OF PARENTS PLACING THEIR CHILDREN AT THE CRISIS NURSERY WERE FEMALE, 92% WERE SINGLE PARENTS, AND A STAGGERING 43% OF FAMILIES WERE EXPERIENCING HOMELESSNESS.
