**SECOND AMENDED AND RESTATED
ARTICLES OF INCORPORATION
OF
STORE TO DOOR**

Store To Door (the "Corporation"), a nonprofit corporation organized and existing under the Minnesota Nonprofit Corporations Act, Minnesota Statutes, Chapter 317A (the "Act"), hereby certifies as follows:

WHEREAS, the original Articles of Incorporation of Social Technologies for a Livable Community Incorporated (the "Original Articles") were filed with the Office of the Secretary of the State of Minnesota on October 4, 1982, in accordance with the Act;

WHEREAS, the Original Articles were amended and restated, as set forth in the Restated Articles of Incorporation of Store to Door (f/k/a Social Technologies for a Livable Community Incorporated) (the "Restated Articles"), and filed with the Office of the Secretary of the State of Minnesota on April 5, 1991, in accordance with the Act;

WHEREAS, the Second Amended and Restated Articles of Incorporation of the Corporation, as set forth below, have been duly adopted by the Board of Directors, in accordance with the Act

NOW THEREFORE, pursuant to the provisions of the Act, the Corporation hereby amends and restates its Articles of Incorporation so as to supersede the existing Restated Articles on file with the Secretary of State, as follows:

ARTICLE I

Name

The name of the corporation is: Help at Your Door.

ARTICLE II

Registered Office

The registered office of the Corporation shall be located at 8441 Wayzata Boulevard, Suite 160, Golden Valley, MN 55426. There shall be no registered agent.

ARTICLE III

Purposes

The Corporation is organized and shall be operated exclusively for charitable, scientific and educational purposes within the meaning of Sections 501(c)(3) and 170(c)(2) of the Internal Revenue Code of 1986, as amended, or the corresponding provision of any future United States Internal Revenue Law (the "Code"), and specifically to support and to provide various services, including but not limited to grocery assistance, home support, and transportation, to elderly and disabled persons so that those persons can continue to live in their homes as they age.

ARTICLE IV

Powers

The Corporation shall have and exercise any and all powers and do and engage in such other acts and activities not expressly prohibited by the Articles of Incorporation and the Bylaws of the Corporation or the applicable laws of the State of Minnesota in furtherance of the purposes above set forth.

Notwithstanding any other provisions of the Articles of Incorporation, the Corporation shall not carry on any activities not permitted to be carried on by a corporation exempt from federal income tax under Section 501(c)(3) of the Code.

ARTICLE V

Members

The Corporation shall not have members.

ARTICLE VI

Duration

The duration of the Corporation shall be perpetual.

ARTICLE VII

No Capital Stock

The Corporation shall not have capital stock.

ARTICLE VIII

Board of Directors

The general management of the business and affairs of the corporation shall be vested in a Board of Directors. The number, qualifications, term of office, method of election, powers, authorities and duties of the directors of the Corporation, the time and place of their meetings, and such other provisions with respect to them as are not inconsistent with the express provisions of these Articles of Incorporation shall be as specified in the Bylaws of the Corporation.

Any action required or permitted to be taken at a meeting of the Board of Directors may be taken without a meeting by written action signed, or consented to by authenticated electronic communication by that number of directors that would be required to take the same action at a meeting of the Board of Directors at which all directors were present; provided that all directors must be notified immediately of its text and effective date.

ARTICLE IX
No Pecuniary Gain

The Corporation shall not afford pecuniary gain, incidentally or otherwise, to its members, directors, or officers. No part of the net earnings of the Corporation shall inure to the benefit of its members, directors, officers or any other individual, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof.

ARTICLE X
Restrictions on Political Activity

Except as otherwise permitted under Sections 501(c)(3), 501(h) or 4911 of the Code, no part of the activities of the Corporation shall be carrying on propaganda or otherwise attempting to influence legislation or participating in or intervening in (including the publication or distribution of statements) any political campaign on behalf of (or in opposition to) any candidate for public office.

ARTICLE XI
No Personal Liability

The members, directors and officers of the Corporation shall not be personally liable for the acts, debts, liabilities or obligations of the Corporation to any extent whatsoever; nor shall any of the property of the members, directors or officers of the Corporation be subject to the payment of any debts or obligations of the Corporation.

ARTICLE XII
Amendments


These Articles of Incorporation of the Corporation may be amended from time to time by the affirmative vote of two-thirds of the entire Board of Directors, provided that notice of the proposed amendment shall be given in advance of such meeting to the directors.

ARTICLE XIII
Dissolution

The Corporation may be dissolved in accordance with the laws of the State of Minnesota. No member, director or officer of the Corporation or any private individual shall be entitled to share in the distribution of any of the Corporation's assets on dissolution of the Corporation. Upon dissolution of the Corporation, the Board of Directors shall, after paying or making provision for the payment of all liabilities of the Corporation and all costs and expenses incurred by the Corporation in connection with such dissolution, dispose of all assets of the Corporation exclusively for the purposes of the Corporation, in such manner, or to such organization or organizations organized and operated exclusively for charitable, educational, religious or scientific purposes as shall at the time qualify as an exempt organization or organizations under Section 501(c)(3) of

the Code, as the Board of Directors shall determine. Any assets not so disposed of shall be disposed of by the district court of the county in which the Corporation has its principal office, exclusively for one or more exempt purposes within the meaning of Section 501(c)(3) of the Code or corresponding sections of any future tax code, or to such organization or organizations as such court shall determine which are organized and operated exclusively for such purposes.


