PRISM is a 501(c)(3) nonprofit organization founded in 1970 by community members concerned about local hungry and homeless families. What started as an informal effort has since evolved into a strong, sustainable organization that is considered a leading provider of basic needs services in the northwest suburbs. Our mission is to provide social services and connections that empower people in our community to build healthy, stable lives. Our core values of collaboration, innovation, dignity and accountability guide our work. The continued generosity of the community enables us to meet the food, clothing, and housing needs for nearly 6,000 low-income children, adults and seniors each year. PRISM's Marketplace Food Shelf, our primary program, serves residents of Golden Valley, New Hope, Robbinsdale, Crystal and Plymouth (east of 494), as well as residents of surrounding cities. Between 10/1/17-9/30/18, more than 750 families visited the Food Shelf. Other core services include Housing and Children's Programs, which serves residents of Hennepin County, and Shop for Change Thrift Shop, which is open to the public.

Form 990, Part III, Line 4b:

The Marketplace Food Shelf ensures children, adults, and seniors do not go hungry. More than 750 families visited the Food Shelf each month between 10/1/17-9/30/18. In addition, we distributed 984,270 pounds of food between 10/1/17-9/30/18, which is a 14% increase over 10/1/16-9/30/17. Prior to accessing the Food Shelf, participants meet with a case manager to discuss concerns. Most participants are experiencing many challenges that threaten their stability (e.g., job loss, sudden increase in rent, medical or transportation issues). Case managers provide referrals to community resources to address these issues. They may also provide gift certificates to the Thrift Shop to access clothing and housewares, as well as emergency rental assistance to prevent eviction. Between 10/1/17-9/30/18 we provided 621 families with gift certificates to the Thrift Shop and assisted 105 families with case management services. This individualized approach is a unique model that facilitates a more effective prevention. We employ a "choice model," where participants select their own hygiene products and approximately one week's worth of free groceries to fit their dietary needs and preferences. Participants may access the Food Shelf one to two times per month, and the free shelf (stocked with overflow perishables) as often as needed. On average, participants visit the Food Shelf four times per year. We also increased access to healthy food through four free produce distributions during the summer and early fall months, a total of 2,128 people received 19,672 pounds of produce through this service. In addition, we serve as the Supplemental Nutrition Assistance Program (SNAP) Benefits Coordinator at the Golden Valley and New Hope farmers' markets. This provides an opportunity for SNAP benefit recipients to buy fresh food from local farmers. Between 10/1/17-9/30/18 we served 109 families at local farmers markets. Participants of the Food Shelf were also invited to participate in Children's Programs, which provided more than 1,000 children with school supplies, holiday toys, new baby essentials and birthday gifts between 10/1/17 - 9/30/18.

Form 990, Part III, Line 4c:

PRISMs Housing Programs (Homelessness Prevention and Rapid Rehousing) keep families safely and stably housed. Between 10/1/17-9/30/18 we helped 105 families avoid the loss of their home due to facing a financial crisis. This program offered emergency financial assistance, advocacy with landlords to help avoid costly housing court proceedings and eviction, assistance with applications for energy assistance programs, and referrals for community resources to address other issues like transportation, employment and mental health care. Rapid Rehousing Program helped 29 families between 10/1/17-9/30/18 who were living in shelters transition to stable housing, or assisted families with rental assistance to keep their housing. This program offers intensive, individualized case management to help families find and secure appropriate housing, connect to community resources, and stabilize quickly. Participants of the Housing Programs may also access the Food Shelf, Thrift Shop, and Children's Programs as they work to regain stability.
