Lending Home ownership preservation through a variety of below market rate home renovation lending products to revitalize our community's aging housing stock and ensure the success of our lower income homeowners ONE ROOF ALSO PROVIDES LENDING PRODUCTS FOR REVITALIZATION OF RENTAL HOUSING OCCUPIED BY LOWER INCOME INDIVIDUALS Community residents in Duluth access rehabilitation lending services through the Housing Resource Connection--a collaboration between One Roof, HRA of Duluth, Ecolibrium3, Arrowhead Economic Opportunity Agency, and the City of Duluth One Roof staffs the intake, underwriting, and loan closings for the Housing Resource Connection One Roof also provides down payment and closing cost assistance loans for lower income buyers who have attended Homebuyer Education classes and are purchasing in Duluth In addition, One Roof partners with Essentia Health to provide down payment and closing cost assistance of \$2,000 per household for Essentia employees who purchase in the Hillside, Lincoln Park, or West Duluth neighborhoods Housing Resource Connection produced 144 loans (97 households) in 2016 for a total of \$2,415,424 in loan funds deployed

Multifamily Housing Development Services Turn-key housing development services for affordable rental housing owners, managers and service providers to provide affordable rental housing opportunities and prevent homelessness of lower income households in our community The primary focus in 2016 was the construction on Gateway Towers, a 150 unit building that houses lower income people in Duluth Construction began in 2016 and is scheduled for completion in 2017 One Roof also conducted preliminary work on several possible projects in its area, several of which may go forward into development in coming years

Tenant-Landlord Connection (TLC) program This line of business provides education, information, and problem solving assistance as a way to improve tenant-landlord relations and decrease the amount of housing evictions in our community The mission of TLC is to ensure that stable rental housing exists by educating existing and potential landlords and tenants regarding their respective rights and responsibilities and by meditating disputes between landlords and tenants In 2016, the TLC served a total of 598 households and prevented 18 evictions
