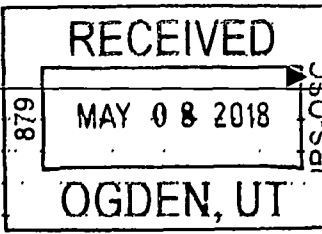

Many participants who receive spiritual listening services find increasing stability in their lives and an increased desire and capacity to give back to their community.

City House continues to make a difference, utilizing twenty-eight trained volunteers to meet unmet spiritual needs of participants in partner organizations. In 2017 we added two new agency partners, a faith community providing a community meal, and a larger non-profit providing shelter, housing, and recovery programs. City House has a total of fourteen programs serving ten partner agencies. Our volunteers spent 948 hours spiritual listening and made 2683 contacts with individuals around the Twin Cities metro area.

In addition, training programs are offered to put participants in contact with those on the margins of society and to develop spiritual listening skills. Four "pilgrimages" (urban immersion experiences) were offered and four spiritual listening trainings were held, along with one workshop for volunteers on ending homelessness for volunteers.
