The Organization provides services to "Persons Living with or affected by HIV/AIDS" (PLWHA). In 2016, the Organization served 324 PLWHA. Of those served 68 were new to the Organization. Partner clinics and infectious disease specialist provided primary medical care to 244 PLWHA and made 445 visits. Staff and partner agencies conducted 755 HIV and 474 Hepatitis C rapid testing and provided prevention counseling. Case Managers served 274 clients. Over 8,600 individuals in the community received educational and outreach information.
