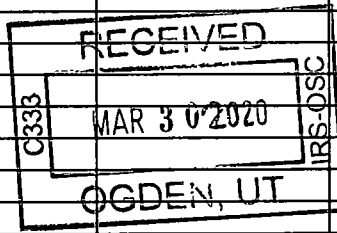

Statement for 2018 Amended Form 990-T

RS Eden is amending its 2018 Form 990-T for the retroactive repeal of Internal Revenue Code Section 512(a)(7), amounts paid for qualified transportation fringe benefits.

Specific changes include:
