DURING 2016-17, FOUR INSTITUTIONS PARTICIPATED IN THE CATALYZE PROGRAM: AUGSBURG COLLEGE, THE COLLEGE OF SAINT BENEDICT, SAINT JOHN'S UNIVERSITY, AND SAINT CLOUD STATE UNIVERSITY (SCSU). OVER THE COURSE OF THE YEAR, EIGHT COACHES SERVED 294 NEWLY RECRUITED STUDENTS AND 483 STUDENTS RECRUITED INTO COLLEGE POSSIBLE DURING HIGH SCHOOL. EARLY DATA ANALYZED IN OCTOBER 2017 SHOWS THAT STUDENTS RECEIVING COLLEGE POSSIBLE SUPPORT HAVE AN ANNUAL RETENTION RATE HIGHER THAN THEIR PEERS BY ABOUT 8 PERCENT.
