MOORE FAMILY CONNECTIONS PROGRAM - THE STRENGTHENING FAMILIES PROGRAM (SFP) IS A FAMILY SKILLS PROGRAM. THE GOALS OF SFP ARE TO INCREASE FAMILY STRENGTHS AND ADDRESS BEHAVIORAL, EMOTIONAL, ACADEMIC, AND SOCIAL PROBLEMS. SFP BUILDS ON PROTECTIVE FACTORS BY IMPROVING FAMILY RELATIONSHIPS, PARENTING SKILLS, AND THE YOUTH'S SOCIAL AND LIFE SKILLS. SFP IS BASED ON COGNITIVE BEHAVIORAL SOCIAL LEARNING THEORY AND FAMILY SYSTEMS THEORY.

SFP CONSISTS OF 7 OR 14 CONSECUTIVE WEEKLY SKILL-BUILDING SESSIONS. CLASSES ARE HIGHLY INTERACTIVE AND FUN. PARENTS AND CHILDREN WORK SEPARATELY IN TRAINING SESSIONS AND THEN PARTICIPATE TOGETHER IN A SESSION PRACTICING THE SKILLS THEY LEARNED EARLIER. CHILDRENS' SESSIONS

OUR IN-SCHOOL MENTORING PROGRAM IS BASED AT SOUTHERN MIDDLE SCHOOL IN ABERDEEN, NORTH CAROLINA. THE INITIAL PROGRAM WAS FUNDED THROUGH A FEDERAL GRANT FROM THE DEPARTMENT OF PUBLIC INSTRUCTION. THE PROJECT IS CURRENTLY IN ITS FIFTH YEAR AND FUNDED THROUGH UNITED WAY OF MOORE COUNTY AND DONORS FROM THE MOORE COUNTY COMMUNITY. OUR MENTORING COORDINATOR PAIRS CHILDREN AT SOUTHERN MIDDLE SCHOOL WITH COMMUNITY VOLUNTEERS TO MEET FOR ONE HOUR A WEEK. THIS PROGRAM HAS HAD A GREAT IMPACT ON THE INDIVIDUAL STUDENTS AND THE SCHOOL AS A WHOLE. STUDENTS WHO ARE INVOLVED IN IN-SCHOOL MENTORING EXPLORE CAREERS, GET ACADEMIC ASSISTANCE, COMPLETE COMMUNITY SERVICE PROJECTS, TAKE EDUCATIONAL FIELD TRIPS, ATTEND SUMMER CAMP, PARTICIPATE IN COMMUNITY EVENTS AND MEET WITH A MENTOR FOR 1 HOUR EACH WEEK.

THE COMMUNITY MENTORING PROGRAM MATCHES ADULT VOLUNTEER MENTORS WHO ARE WILLING TO GIVE THEIR TIME, ENERGY, AND COMPASSION TO A MOORE COUNTY YOUTH FOR ONE YEAR. OUR MENTORS WORK WITH YOUNG PEOPLE WHO ARE BETWEEN THE AGES OF 6 AND 17 AND FACE MANY CHALLENGES. A MENTOR CAN HELP SET AND ACHIEVE GOALS, IMPROVE BEHAVIORS AND RAISE SELF-ESTEEM. OUR MENTORS SPEND AN AVERAGE OF 1-2 HOURS A WEEK FOR A YEAR WITH THEIR YOUNG PERSON WORKING ON GOALS AND SKILL BUILDING. COMMUNITY MENTORING OFFERS ACTIVITIES THROUGHOUT THE YEAR TO SUPPORT AND ENCOURAGE THESE FRIENDSHIPS.
