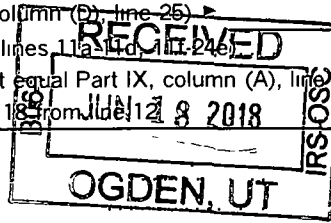

THE CONSIGNMENT SHOP PROVIDES A MARKETPLACE WHERE HANDCRAFTED GOODS ARE PURCHASED AND SOLD OR CONSIGNED AND SOLD. TOTAL PAYMENTS IN THE AMOUNT OF \$204,128 WERE MADE TO 45 CONSIGNORS DURING THE CALENDAR YEAR 2017. THE TEA ROOM PROVIDES A PLACE WHERE INDIVIDUALS WHO ARE OTHERWISE UNEMPLOYABLE DUE TO AGE, HANDICAPS, LACK OF JOB SKILLS, LANGUAGE OR CULTURAL BARRIERS, OR UNAVAILABILITY OF RESOURCES CAN DEVELOP SKILLS AND BUSINESS CONCEPTS.
