Pt VI, Line 15a A review of compensation was done several years ago and, since the economic conditions have not changed measurably, the assumption is that the executive director's and the other employees' compensation are still below market.

Pt VI, Line 15b In the future, when more net revenue is generated, a comprehensive review of salaries and benefits will be made with the goal of increasing compensation.

Pt VI, Line 12c One of the board members maintains the annual conflict of interest forms prepared by each board member. No conflict has arisen to date, but appropriate steps would be taken to monitor the situation based on the type of conflict involved.

Pt VI, Line 1a The executive director of the organization is a member of the board of directors and is president, allowed by Missouri law. He is a voting member of the board except for matters related to his compensation and any other employment issues that might arise.

Other Pt.IV, line 9 - YEHS' housing counseling program generated \$875 of fees from clients who obtained reverse mortgages with staff's assistance. The fees were received out of the mortgage proceeds. At no time did YEHS hold any funds for clients. There is no charge for basic housing counseling services.

Other Pt.XII, line 2a - The organization obtains reviewed financial statements every other year to comply with a government funder's requirements. It also contracts with an independent CPA to perform accounting oversight functions on an ongoing basis, prepare the drafts of the review financial statements, and prepare the 990's.
