YEHS' rental property provided affordable apartments to 109 individuals and families. YEHS has a partnership with Humanatri Homeless Shelters that provides transitional housing and supportive services to families that were formerly homeless. Rent is based on 30% of household income. Several families have moved into market housing or purchased their own homes after residing in YEHS apartments and achieving the financial goals agreed to in consort with the YEHS housing counselor. YEHS owns several commercial storefronts in the neighborhood - several restaurants, an insurance agency, and an art gallery, all below market. Fourteen artists rent space at the gallery, have juried art shows monthly, and offer classes. YEHS also provides space and some supplies for a senior citizen Saturday meals program for area seniors, some of whom are YEHS tenants.

Form 990, Part III, Line 4b:

Rental property management and maintenance services were provided to real estate partnerships in which YEHS is a partner. These entities provided housing to 170 low- and moderate-income individuals and families.

Form 990, Part III, Line 4c:

The YEHS/HUD Counseling program received funding from the National Housing Resource Center for participating in the city-wide St. Louis Housing Fair and from the US Dept of Housing and Urban Development. The counseling program served 173 clients. Services provided were Homeless - 25, Rental - 10, Pre-Purchase - 70, Reverse mortgage counseling - 40, and Mortgage delinquency - 28. The outcomes were five of the homeless clients received permanent housing, ten clients purchased homes, forty clients raised their credit scores, twenty clients received reverse mortgages, and twelve received loan modifications.
