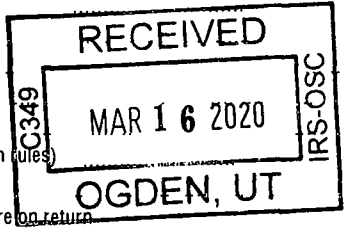

AMENDED RETURN STATEMENT: FILING AN AMENDED RETURN DUE TO THE REPEAL OF SECTION 512(A)(7). THE ORIGINAL FILING REPORTED \$18,005 ON LINE 34, AMOUNTS PAID FOR DISALLOWED FRINGES. PER THE TAXPAYER CERTAINTY AND TAX RELIEF ACT, THE TAX ON AMOUNTS PAID FOR DISALLOWED FRINGES WAS RETROACTIVELY REPEALED, LINE 34 HAS BEEN UPDATED TO SHOW \$0 AS TAXABLE INCOME RELATED TO AMOUNTS PAID FOR DISALLOWED FRINGES. LINE 50G WAS UPDATED TO INCLUDE AMOUNTS PAID WITH THE ORIGINALLY FILED 990-T. THIS ALSO CHANGED LINE 54, OVERPAYMENT, TO REFUND ALL OF THE PRIOR TAX PAID OF \$3,633.
