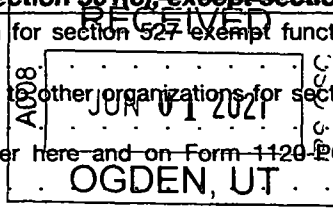

#3. The organization, in accordance with bylaws, contracts with an Executive Director to be the chief executive of the organization responsible for all management functions. The Executive Director manages and directs all activities as prescribed by the Board of Directors and is responsible to the Board.

#6. Membership in the organization is open to persons interested in the economic development of the State of Missouri. Classes of membership are Professional, Associate, Corporate, Community, Out of State, Student, Honorary member, and Life Member. All classes of membership have voting rights except Community, Out of State, Student, and Honorary Member.

#7a. Board members are elected by secret ballot voting of voting rights members at the Annual Meeting from a slate of officers selected by a Nominating Committee appointed by the President.

#7b. The Constitution and By-Laws may be amended at any Annual Meeting, special meeting, or meeting called for that purpose by a majority vote of those voting rights members present. The Board of Directors then must act within the confines of the bylaws in making governance decisions and the Executive Director carries out the directives of the Board.

#11. The Executive Director reviews the Form 990 after it has been prepared by a CPA.

#12c. All board members are required to annually read and sign a written conflict of interest policy which is then kept on file. Due to the small size of the entity and nature of its operations, there have been no enforcement issues regarding conflict of interest.

#15a. The contract for the Executive Director is renewed annually and approved by the entire board of directors.
