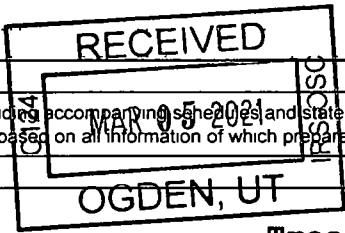

Taxpayer hereby amends the 2017 (7/1/2017 - 6/30/2018) Form 990 to correct Contribution Income and report the sale of the building.

The Gross Proceeds from the sale of their building \$245,000 were inadvertently included in Contribution Income on Form 990, line 8 Current Year and on Form Schedule B, Part 1, Item 6 rather than as Gross Proceeds from the Sale of their Building. The building on Edmond was sold on 8/9/2017 and the money put in escrow along with other contributions to construct a new building at a different location. That building was completed in September 2019.

The return now reflects the gain on the sale of the building \$83,059 (\$245,000 - \$161,941). In addition to receiving cash of \$245,000 for the sale they also received Land with a FMV of \$55,000 at the location where they will build the new building. This has now been shown as a non-cash contribution and added as an asset to balance sheet.

Depreciation was corrected from \$6,676 to \$5,628 to reflect the disposal of the building.

The building and accumulated depreciation were removed from the balance sheet.
