Food Pantry - distribution of food to those in need. A total of 17,476 individuals received USDA commodities and community-donated food, of which 3072 elderly/disabled persons were additionally enrolled in the CSFP Senior Box program, 1876 received emergency food & 2880 children's backpacks carried food home weekly using the Backpack program. Community Garden & Restorative Justice programs donated fresh produce seasonally. Food credits for our agency in partnership with Ozark's Food Harvest were earned with an annual Hunger Challenge match grant through Walmart Foundation's State Giving program. Our four satellite locations enabled recipients in remote areas of Texas County access to food while alleviating transportation issues. Funding was used to pay wages of one part-time food manager. Another part-time employee helped transport, weigh, stock food and maintain the cleanliness/repair of all areas. Five regularly scheduled volunteers helped with daily food distribution, client intake and record keeping; eleven more served monthly with satellite distribution duties. Numerous other volunteers and 1 SCSEP worker assisted in packaging, sorting & stocking food for distribution readiness. Church Youth groups/adults bagged Backpack food for distribution the last day of each school week. Approximately 2,400 volunteer hours were clocked in all aspects of food distribution.

4b (Code:) (Expenses \$ 235241 including grants of \$ 167468) (Revenue \$ 20583)

Emergency Assistance - helped 2,845 persons with rent/mortgage, utilities, lodging, home repair, transportation, clothing, diapers, school supplies & personal hygiene items as well as birth certificates, I.D. cards and GED fees using grant funding and donations. A Thrift shop provides clothing and household items free to those in need and at a reasonable price to those who can afford to buy. One part-time paid manager, with the help of 10 regularly scheduled volunteers, one SCSEP worker and numerous other volunteers sort, clean, display donated items for resale or give-away and operate the cash register. Thrift shop revenue is used for agency operation expenses. Unusable clothing is baled and trucked to a recycling center. An Intake Specialist, paid with grant funding, handles client housing assistance applications, recording, tracking, data input, individual case work and referrals. One SCSEP worker helps with phone calls and record keeping. The Exec. Director makes approval decisions for vendor payment and the part-time bookkeeper/grant writer finalizes the reporting. Close to 3,000 volunteer hours were clocked in all aspects of thrift shop and emergency assistance. An additional 2,200 volunteer hours were spent in coordinating, bell ringing and money counting during the annual Salvation Army Red Kettle campaign, for which our agency is the Texas County Service Unit.

"Together in Hope" prescription assistance program provided advocacy to almost 200 indigent individuals, many referred by health-care providers. In collaboration with the prescriber, eligible patients were enrolled into pharmaceutical company assistance programs to obtain high-dollar, name-brand medications free, with an estimated \$300,000 annual savings. Grant funds and donations allowed for the purchase of necessary interim medications and diabetic supplies to 47 at-risk persons as well as providing wages for a part-time coordinator/Patient Advocate. A one-time doctor or dentist visit for the uninsured including transportation if needed, was paid with available funding.

PART I, LINE 2. Each client/head of household completes an application for the specific assistance needed at time of each request, or semi-annually for USDA/CSFP commodity programs. Food distribution follows USDA guidelines for age for disability status & Federal poverty level income requirements; client shows I.D. and brings commodity card to pick up food monthly. Rent & utility assistance follows Missouri Housing Trust Fund income guidelines using Maximum Income Fair Market Rates by county; all adult household members must have current I.D. Social Security card, proof of income and vendor's bill or lease agreement which are verified before funding, each request is entered into a state database system as mandated by Missouri Housing Development Commission. Trust Fund grant requirements; two compliance site visits are performed by MHDC staff to verify records and an annual financial audit of grant funding. Tracking sheets and client files are maintained and tallied quarterly for assistance recipient numbers & type of assistance granted; reports are submitted to MHDC; records are kept for 7 yrs from date of client contact whether or not funding was granted. Our food bank, Ozarks Food Harvest requires monthly reporting of recipient statistics and conducts 2 site visits annually to audit records and verify compliance in areas of food storage and handling along with Missouri State Health Dept. periodic inspections. Grant funding in most cases in 2016 was limited to Texas County, Missouri residents. *In cases where I.D. cards are not available, we provide application assistance and pay appropriate fees to help clients obtain necessary documents.
