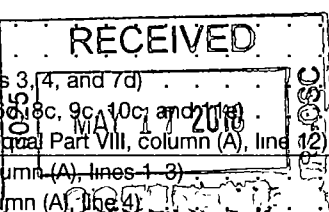

Food Pantry - distribution of food to those in need. A total of 16,340 individuals received USDA commodities and community-donated food, of which 2867 elderly/disabled persons were additionally enrolled in the CSFP Senior Box Program and 1723 received emergency food. In addition, 3724 children's backpacks carried food home weekly using Weekend School Backpack program. Restorative Justice program donated fresh produce seasonally. Food credits for our agency in partnership with Ozark's Food Harvest were earned with an annual Hunger Challenge match grant through Walmart Foundation's State Giving program. Our four satellite locations enabled recipients in remote areas of Texas County access to food while alleviating transportation issues. Funding was used to pay wages of one part-time food manager. Another part-time employee helped transport, weigh, stock food and maintain the cleanliness/repair of all areas. Four regularly scheduled volunteers helped with daily food distribution, client intake and record keeping; eleven more served monthly with satellite distribution duties. Numerous other volunteers and 1 SCSEP worker assisted in packaging, sorting, & stocking food for distribution readiness. Church youth groups/adults bagged Backpack food for distribution the last day of each school week. Approximately 2335 volunteer hours were clocked in all aspects of food distribution.

4b (Code:) (Expenses \$ 213293 including grants of \$ 123648) (Revenue \$ 20,520)

Emergency Assistance - helped 1666 persons with rent/mortgage, utilities, lodging, home repair, transportation, clothing, prescriptions, school supplies, & personal hygiene items as well as birth certificates, ID cards and GED fees using grant funding and donations. A Thrift Shop provides clothing and household items free to those in need and at a reasonable price to those who can afford to buy. One part-time paid manager, with the help of 10 regularly scheduled volunteers, one SCSEP worker, & numerous other volunteers sort, clean, & display donated items for resale or give-away and operate the cash register. Thrift Shop revenue is used for agency operation expenses. Unusable clothing is baled & trucked to a recycling center. An Intake Specialist and one SCSEP worker handle client phone calls and record keeping. The Executive Director makes approval decisions for vendor payment and the part-time bookkeeper/grant writer finalizes the reporting. Close to 2423 volunteer hours were clocked in all aspects of Thrift Shop and emergency assistance. An additional 2262 volunteer hours were spent in coordinating, bell-ringing, and money counting during the annual Salvation Army Red Kettle Campaign, for which our agency is the Texas County Service Unit. A patient assistance program provided advocacy to 104 individuals.
