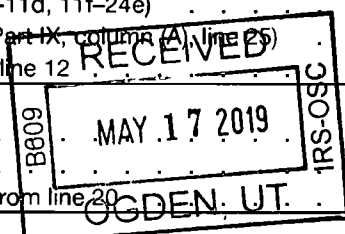

 Food Pantry-distribution of food to those in need. A total of 10,205 individuals received USDA commodities and community-donated food, of which 2736 elderly/disabled persons received CSFP Senior Box and 1289 received emergency food. Restorative Justice program donated fresh produce seasonally. Our four satellite locations enabled recipients in remote areas of Texas County access to food while alleviating transportation issues. Funding was used to pay wages of one part-time food manager. Another part-time employee helped transport, weigh, and maintain the cleanliness/repair of all areas. Four regularly scheduled volunteers helped with daily food distribution, client intake and record keeping, eleven more served monthly with satellite distribution duties. Numerous other volunteers and 1 SCSEP worker assisted in packaging, sorting, and stocking food for distribution readiness. Approximately 2000 volunteer hours were clocked in all aspects of food distribution.

 Emergency Assistance- helped 1950 persons with rent/mortgage, utilities, lodging, home repair, transportation, clothing, prescriptions, school supplies, and personal hygiene items as well as birth certificates, ID cards and GED fees using grant funding and donations. A Thrift Shop provides clothing and household items free to those in need and at a reasonable price to those who can afford to buy. One SCSEP worker, with the help of 10 regularly scheduled volunteers, one part-time worker, and numerous other volunteers sort, clean, and display donated items for resale or give-away and operate the cash register. Thrift Shop revenue is used for agency operations expenses. Unusable clothing is baled and trucked to a recycling center. An Intake Specialist and Intake Assistant handle client phone calls and record keeping. The Executive Director makes approval decisions for vendor payment and the part-time bookkeeper/grant writer keeps financial records. Close to 2000 volunteer hours were clocked in all aspects of Thrift Shop and emergency assistance. An additional 2200 volunteer hours were spent in coordinating, bell-ringing, and money counting during the annual Salvation Army Red Kettle Campaign, for which our agency is the Texas County Service Unit.
