HOUSING We partner with low income individuals and families in Jefferson City and the Cole County surrounding areas to help build or refurbish homes with the goal of homeownership. Habitat Partner Families must show a willingness to partner with us by volunteering 350-450 hours of sweat equity either on other families houses or their own build before purchasing their home. Habitat finances the homes with a 20-25 year interest-free mortgage. In FY 2017 we sold 6 homes to Jefferson City Families and ended our fiscal year with five homes under construction.

RESTORE The Habitat ReStore accepts donations of furniture, appliances, household goods, plumbing fixtures, doors, windows, cabinets and countertops. This ReStore is one of our largest fund raisers, serving 4 purposes in the community. It keeps thousands of pounds of materials out of the landfills, allows for a place for residents, who no longer have a use for their items, a place to donate them, offers opportunities for bargain seekers to purchase used items and save money, and it is one of our largest fund raisers as mentioned above.

FAMILY SUPPORT AND EDUCATION Once an applicant is approved by the Board, they are matched with a Support Partner. This Partner mentors them through the process of home ownership and the completion of their build. While being a Partner Family can take 12-18 months, they attend a monthly homeownership education class. Required classes include Personal Finance, City Codes, Mortgage Closing documents, household maintenance, homeowners insurance, and Wills and Trusts. These courses are held at the Habitat office conference room once a month at no cost to families.
