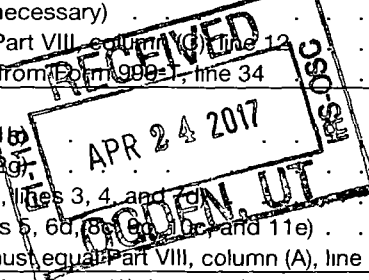

We offer HiSET preparation, individual and group counseling, career counseling, parent mentoring, yoga and computer classes. On-site childcare is provided to participants' children offering a pre-K curriculum

In the 2015-16 academic year Women In Charge served 258 individuals. Fifty-three women and 44 children enrolled in the program, 100 women were served through crisis intervention and referrals. 96% of women tested after 60 hours of instruction progressed at least one level in the Tests of Adult Basic Education (TABE), compared to the state and federal target of 50%. Women tested gained an average of 2.4 grades in reading, 4.2 grades in mathematics and 4.5 grades in language. 88% of participants improved in life skills and stability such as achieving stable housing or getting out of an abusive relationship. 90% showed gains in parenting skills, and 83% engaged in developmental activities with their children.
