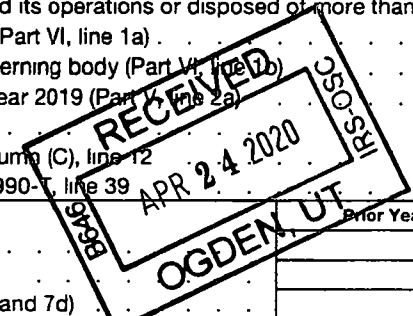

We offer Adult Education and Literacy instruction, HiSET preparation, individual and group counseling, career counseling, parent mentoring, yoga and computer classes. The program is free of charge. A free site children's program is available to participants. September through May, hours are Monday through Thursday from 9:00 a.m. to 2:30 p.m. Summer hours are Monday through Thursday from 9:00 a.m. to 12:30 p.m.

Women in Charge provided HiSET preparation, counseling, nutrition classes, parenting, computer classes, yoga and financial management classes to 50 women in the last academic year, and provided outreach to another 87 women. Aside from passing the HiSET (high school equivalency exam), women are tested after 60 hours of course work to track their improvement. 60 hours represents approximately 1 1/2 weeks of work. In the last three years, average grade level increases have varied from .93 to 4.28. Participants vary widely every year, both in beginning grade level and in length of time they can stay in the program. In 2018-2019 participants increased by .93 grade levels in reading, by 1.5 grade levels in language and 2.64 grade levels in math after 60 hours of instruction. Also, 38 out of 50 or 76% of women improved life skills and stability (such as achieving stable housing or getting out of abusive relationships during the academic year.
