The Calvary Community Wellness Center provides structured fitness opportunities and information to youth and families living and working in urban Kansas City. The 10,000 square foot warehouse located at 3002 Holmes Street has been converted into a state of the art fitness center to serve youth and families in the target group. Health screenings, nutrition demonstrations and fitness classes are among the program offerings. The health of people living in Kansas City is very important to the CCON. Over the years, we have learned that many of the diseases that people suffer with could be prevented or controlled. The conclusion is obvious - it makes more sense to keep people healthy than wait until they are broken and need medical attention. We have created a safe, friendly, culturally diverse gathering place where individuals from all walks of life can establish individual fitness goals, receive critical health information and start on a journey of wellness. We have initiated a comprehensive approach to good health through a combination of assessment, education, motivation, and re-evaluation. This approach includes assisting people as they manage lifestyle, risk identification, fitness enhancement, health education, and the resources necessary to improve our members' health through long-term, personal action plans.

Form 990, Part III, Line 4b:

Helping Youth Plan for Excellence (HYPE) is a media leadership group that creates a positive setting for urban youth ages 10- 21. The project utilizes student involvement in media as the vehicle to establish ongoing youth development activities. Since 1999, HYPE members have produced quality programming giving accurate, culturally sensitive HIV/AIDS and substance abuse prevention information to their peers in an up-beat entertaining way. Students work to create stage performances that speak to their peers in positive ways. Students reached over 3,000 youth in their performances at Kauffman Performing Arts Center.

Education and awareness about HIV/AIDS prevention is observed annually the first full week in March. Organized forums and events are used to bring about positive change in the African American community. Area African American churches are mobilized to educate the community on the risk factors associated with HIV/AIDS and reduce the spread of the disease. CCON is a certified partner of the Balm of Gilead and is the convener and fiscal agent for the local observance. HIV Prevention & Compassion Tool Kits are disseminated to congregants and affiliates. CCON staff and volunteers provide technical assistance and resources including testing.

Healthy Faith is a new healthy-living program wherein CCON mobilized a coalition of three AA churches in the urban core to implement interventions to address the community's wellness and priority health disparities in Kansas City, MO. In year 1, the three partner churches are Calvary Temple Baptist, Second Baptist, and Paseo Baptist, which collectively serve 775 congregants. The churches are located in three urban core, high-need zip codes 64109, 64128, and 64108. The components of this program include Healthy Faith Church Advisory Board. Each church will appoint Health Liaisons from its congregation. These individuals, along with CCON staff and representatives from partner organizations, comprised Healthy Faith Church Advisory Board. These Health Liaisons act as conduits of information that will communicate with their own parish. This group meets monthly to participate in a curriculum of healthy-living training, with the monthly meetings also providing a forum to share each congregation's needs and concerns. The program is intended to flexibly allow each congregation to construct its own activities based on unique needs expressed by each. Rather than building a program and asking people to come, Healthy Faith is designed for community input at each level.

KC Fun & Fitness Day presents a carnival-like atmosphere for youth and families filled with sports and athletic events combined with numerous health screenings, healthy food samples, group and individual fitness demonstrations, double-dutch basketball, local music groups and fun family activities. The event is also a launching point for a series of efforts designed to build the capacity of the African American faith communities to provide ongoing health related programs and services organizations, whose goal is to develop, deliver, and support effective health programs for faith and community-based organizations.
