IN 2017, 1,596 CHILDREN WERE SERVED: 1,405 FORENSIC INTERVIEWS, 782 SEXUAL ASSAULT FORENSIC EXAMS AND 434 CHILD AT RISK EXAMS WERE PERFORMED. THE FIRST STEP BEGINS WITH A FORENSIC INTERVIEW. THIS OBJECTIVE, NON-LEADING AGE-APPROPRIATE INTERVIEW IS OFTEN A CHILD'S FIRST OPPORTUNITY TO TALK WITH SOMEONE WHO IS NON-JUDGMENTAL ABOUT THE TRAUMA HE OR SHE HAS EXPERIENCED. INFORMATION GATHERED DRIVES THE MULTI-DISCIPLINARY TEAM'S RECOMMENDATIONS ABOUT WHETHER CHILDREN NEED TO BE TAKEN INTO PROTECTIVE CUSTODY, AS WELL AS WHICH MEDICAL OR MENTAL HEALTH INTERVENTIONS THE CHILD REQUIRES. THE APPROPRIATE MEDICAL TESTS ARE PERFORMED ON SITE. THE OVERALL HEALTH OF THE CHILD IS DETERMINED THROUGH A PAINSTAKINGLY DETAILED EXAM, DOCUMENTING ALL COMPONENTS OF THE CHILD'S HEALTH. EACH CHILD'S MENTAL HEALTH AND DEVELOPMENTAL FUNCTION IS ALSO NOTED WITH APPROPRIATE FOLLOW-UP PERFORMED. IF MORE COMPREHENSIVE SERVICES ARE NEEDED (SUCH AS X-RAYS), THEN THE COMMUNITY COLLABORATIONS EXIST TO ENSURE THESE NEEDS ARE MET AT NO COST TO THE FAMILY.
