Over the course of its 27-year history, VCR has provided leadership in the St Louis region in bringing together hundreds of organizations and community partners to collaboratively address the needs of at-risk children and families. This work has included staffing of the City of St. Louis Mayor's Commission on Children, Youth and Families, and providing backbone support and facilitation for community-wide collaborative initiatives such as the RECC, STLCANN, and System of Care, and LEAP Ahead STL.
