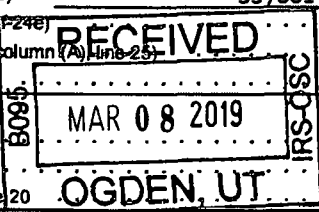

DIAPER COLLECTION AND DISTRIBUTION: THE DIAPER BANK RECEIVED 736,505 DONATED DIAPERS AND DISTRIBUTED 1,405,778 DIAPERS THROUGH 52 PARTNER AGENCIES AT 85 LOCATIONS IN 10 ARIZONA COUNTIES. THERE WERE 56 DRIVES HOSTED THROUGHOUT OUR SERVICE AREA BY CIVIC GROUPS, FAITH BASED ORGANIZATIONS, SCHOOLS, AND CORPORATIONS. A LARGE PORTION OF DONATED DIAPERS ALSO CAME FROM A GRANT FROM THE NATIONAL DIAPER BANK NETWORK. THE TOTAL VALUE OF DONATED DIAPERS WAS \$122,086. WE SERVED 18,412 UNIQUE INDIVIDUALS AT LEAST ONCE DURING THE COURSE OF THE FISCAL YEAR AND OF THOSE, 81% WERE CHILDREN UNDER THE AGE OF 18. VOLUNTEERS DONATED APPROXIMATELY 2,000 HOURS OF TIME TO HELP ENSURE THAT DIAPERS REACHED THOSE IN NEED.
