FI strives to achieve social justice through coupling direct services with leadership development and community organizing. Our mission motto is "Our Community Is Our Campaign"

Ending Gender-based Violence - This program is gender-language-cultural-sexuality-generation-specific that work to end violence against women, children, queer, gender-non-conforming, and transgender folks in the Black and Southeast Asian Communities. Services and activities provided include, but not limited to, domestic violence and sexual assault direct services, supportive advocacy and counseling, outreach, crisis intervention, group activities, community education, leadership development, and community organizing. Including in this program is Black Feminist Future which we are the fiscal sponsor and falls under our Ending Gender-based-violence programming. Under this program we provide one-on-one case management and over 10 weekly programs that are identity/culturally-specific. We have 15-25 participants per program. We have 13 full-time employees, 10 contractual staff, and 3 mental health service providers that support our program. We look for development and trainings for our staff that are DVSA gender-culturally-sexuality-generation-specific in order to provide the best services to meet our clients' needs, due to the limitation of these trainings, they are often out-of-state. We have a weekly food pantry and provide hot meals to our youth and elders.

Community Power Building - FI offers integrated, nonpartisan voter engagement such as civic engagement, Get Out the Vote efforts, community education, and leadership development. We build leadership and train community members in social justice and community organizing to support them in creating change and ending violence. Our grass root campaigns focuses on land, food, self-determination, and education as human rights. Activities under this program include, but not limited to, training and development, canvassing and phone banking efforts, tabling at community events.
