MCFS takes money earned after expenses and directly applies it to the furthering of its charitable causes and mission thus providing MCFS a greater opportunity to serve the community.

MCFS has a 14 year history of providing job-readiness services for older youths and adults through its "preparing older youth for success (POYS)" Job readiness program. The POYS program (1) provides GED instructions for older youth between ages of 18-24 and prepares them to pass the Pennsylvania state general education development (2) Assist participants in enrolling in college/trade school, (3) prepares youth participants to study to sit for the national retail foundation certified customer service examination and, (5) Assist youth participants in obtaining employment with their employers.

MCFS Community Outreach assistance program (COAP) serves as an outreach mechanism for the purpose of enhancing the capacities of the local residents in mitigating and coping with challenging social and economic issues that confront them. COAP services include providing weekly literacy classes for immigrant adults; weekly classes that help immigrants study and prepare to sit for USA Examinations, regular workshop series that address an array of issues related to health and wellness, economic empowerment, prevention, immigration, and citizenship. Community Soccer (Multicultural United Soccer Club) for children and youth between the ages of 4 and 15.
