The Math Pipeline Readiness Project (M-PRéP) is a longitudinal research project designed to increase college graduation rates for underrepresented students by aligning high school math to college and providing targeting college planning services. The South Los Angeles Math (SLAM) Project provides free dual-enrollment college math classes to underrepresented (minority, low-income, first-generation) students in order to increase their college readiness and support services to alumni who have participated in the program since 2013. In the 2017-2018 school year, the project provided professional development to 73 teachers in seven high schools (5 urban in Los Angeles County and 2 rural in the Central Valley) serving 8,906 students in grades 9-11. Additionally, 307 at-risk high school seniors from seven high schools (5 M-PRéP, 2 others in LA County) participated in the SLAM Project, an innovative dual-enrollment math program in collaboration with the California State University (CSU) system. 69% of students earned CSU college math credit through the program. SLAM provided intensive professional development for 14 high school teachers. The CSU provided grant funding for additional intensive professional development for 24 M-PRéP math teachers to align their courses to college. Out of the 179 students who took the dual enrollment course, 87% of them demonstrated college math readiness and 94% matriculated into college. Out of the 165 alumni supported through the program, 60% of them are still persisting toward college graduation. In aggregate, 78% of all our students are currently pursuing their college degrees.
