PERRY COUNTY FOOD COALITION - Catholic Charities serves as the fiscal agent for the Perry County Food Coalition. The 5 food pantries in Perry County come together to share resources with the mission of being more efficient in the pantry system. Food drives that are conducted throughout the county, both non-perishable goods and monetary donations, are brought to Catholic Charities office. The food is weighed and stored until the pantries meet to pick up the food. Funds are distributed on their behalf with the local food bank in Evansville for the individual pantries to use. Due to the efforts of Catholic Charities, on behalf of the food coalition members, an estimated 20,000 people received food during the time period of 7/1/20 through 6/30/21. These are duplicated clients. Due to the pandemic, food insecurities have grown rapidly.
