Clothing and other in-kind items are given out based on the number of people in the household, examples, three shirts per person, one pair of shoes per person, etc. The administration of the Emergency Food and Shelter grant is monitored, and sometimes audited, by both a local Board (United Way of St. Joseph County) and FEMA.
