Mishawaka Food Pantry gave out food to 5,720 families, with 18,698 men, women, and children, providing them enough food for approximately 112,188 meals. Hot lunches were served at the pantry to 16,963 people. The value of clothing given out to 13,534 people was \$219,685, including some of whom also received housewares, furniture, and appliances. Additional services, including showers and laundry assistance, phone and warming centers were provided as well. Bus passes and gas cards provided 252 people with 855 days of transportation. Volunteers gave 5,502 hours of service valued at \$96,892 (which is not reflected in revenues or expenses on pages 9 and 10). Many of our volunteers had received government assistance and were working to "pay back" what they received, boosting their self-esteem while providing a service to people in need. The federal government helped by providing 49,160 pounds of food valued at over \$81,115, which is not reported on pages 9 and 10 since it was consigned product. Through a Wells Fargo grant of \$30,000 and a partnership with the Salvation Army, we fed 4,784 children with a weekend backpack program. This program provided 19,136 meals.
