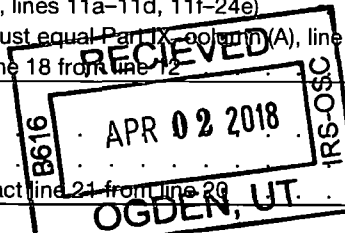

Hope Lives provides opportunities to instill and renew a sense of hope to communities and individuals, one person at a time by providing culturally relevant services to culturally diverse communities, through effective multi-cultural like coaching, prevention, and outreach services.

Nutrition Kitchen is an innovative, fun, and inspirational cooking and nutrition workshop. These planning and cooking activities look comprehensively at a person's health life-style, meal planning within a budget, cooking healthy from a food box, and how healthy eating shapes chronic conditions. The program focuses on a person's strengths, interests, and natural supports. It stresses creating new healthy life-style habits and disciplines, provides education/awareness/prevention activities delivered by peer specialists to promote self-directed whole health. The sessions are held at the Wesley Community Center or on site between 11 am and 2pm, Monday through Saturday.

Community events, i.e bowling, fishing, travel training, hiking, budget shopping, fitness center, golf, movies, and cultural events, etc. are activities held out in the community to provide new experiences and encourage growth and recovery.

4c (Code: ) (Expenses \$ 33,462 including grants of \$ ) (Revenue \$ )

Training classes and programs held on campus, i.e. peer support training, Hope Lab, Jewelry Making, drama class, cooking, ASIST, and Hope Garden. Peer Support Trainings is an agency developed training and certification process that prepares individuals with lived experience in the behavioral health system to promote hope, personal responsibility, empowerment, education, and self-determination in the communities in which they serve. Hope Lab is an 80 hour workshop. This workshop provides an introduction to computer components and how to apply and navigate various computer applications. The curriculum is facilitated by an experienced computer technician provided through AZ StRUT. Individuals will also learn to assemble a computer, identify key components and use utilities to protect and maintain its optimum functionality. Attendees go to take the computer home for recovery, educational, and workforce development activities.
