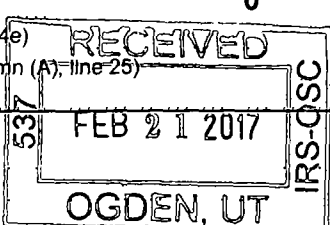

Because of this there was an immediate increased need for accessible housing. No Boundaries built customized fully accessible homes to assist in meeting these needs. Each of these homes has 3 bedrooms, 2 bathrooms, 1 kitchen and a shared living space. Each home is set up as an Independent supported Living, ISL, home and 3 consumers share the rent. No Boundaries functions as a landlord for the consumers that share the homes.**
