THE CONTEST WAS BUILT ON AN IDEA CALLED CROWD ENTREPRENEURSHIP WHERE RESIDENTS HAVE A ROLE IN VOTING FOR THE TYPE OF RETAIL THEY WANT IN THEIR COMMUNITY AND DETERMINING THE WINNER OF THE HATCH CONTEST. SINCE 2011, FIVE WINNERS HAVE BEEN ANNOUNCED, AND FOURTEEN HATCH ALUMNI BUSINESSES HAVE OPENED UP STOREFRONTS. NOW IN ITS SIXTH YEAR, HATCH DETROIT HAS EXPANDED ITS RETAIL ROLE INTO SIX NEIGHBORHOODS IN DETROIT AS PART OF THE DETROIT LION'S LIVING FOR THE CITY INITIATIVE. HATCH DETROIT WILL BE PARTNERING WITH LOCAL COMMUNITY DEVELOPMENT CORPORATIONS (CDC'S) TO DETERMINE AN AREA OF FOCUS THAT WORKS WITHIN THE COMMUNITY'S MASTER PLAN FOR ITS RETAIL STRIP. EXAMPLES INCLUDE IMPROVEMENTS IN SIGNAGE, INTERIOR LIGHTING, WINDOW DISPLAYS, AND OUTDOOR BEAUTIFICATION PROJECTS ALL GEARED TO IMPROVING RETAIL.

HATCH DETROIT IS FUNDED THROUGH DONATIONS FROM THE GENERAL PUBLIC, CORPORATIONS, FUNDRAISING EVENTS AND PERSONAL SOLICITATIONS. ALL FUNDRAISING ACTIVITIES ARE CONDUCTED IN THE STATE OF MICHIGAN. SINCE THE INCEPTION OF HATCH DETROIT IN 2011, ITS LARGEST CONTRIBUTOR HAS BEEN THE DETROIT LIONS, INC. IN TAX YEARS 2012 THROUGH 2015, THE DETROIT LIONS, INC. CONTRIBUTED A TOTAL OF \$592,500, WHICH IS 54% OF THE TOTAL SUPPORT

RECEIVED BY HATCH DETROIT DURING THE FIVE-YEAR LOOK-BACK PERIOD OF THE SCHEDULE A, PART II PUBLIC SUPPORT TEST. THE CONTRIBUTIONS RECEIVED FROM OTHER SOURCES ARE GROWING, BUT NOT AS SIGNIFICANT. AS A RESULT, HATCH DETROIT DOES NOT MEET THE 33 1/3% PUBLIC SUPPORT TEST, HOWEVER, IT DOES MEET THE 10% FACTS AND CIRCUMSTANCES TEST.

HATCH DETROIT MEETS THE FACTS AND CIRCUMSTANCES TEST IN REGULATIONS SECTIONS 1.170A-9(F)(3). HATCH DETROIT'S FY16 PUBLIC SUPPORT PERCENTAGE IS 23.85%, AND HAS BEEN CONSISTENTLY ABOVE THE 10% SUPPORT THRESHOLD ON AN ANNUAL BASIS. THEREFORE THE ORGANIZATION MEETS THE TEN-PERCENT SUPPORT LIMITATION REQUIREMENT AS DESCRIBED IN REGULATIONS SECTION 1.170A-9(F)(3)(I). HATCH DETROIT ALSO MEET THE REGULATIONS SECTION 1.170A-9(F)(3)(II) REQUIREMENT BECAUSE IT IS ORGANIZED AND OPERATED AS TO ATTRACT NEW AND ADDITIONAL PUBLIC OR GOVERNMENTAL SUPPORT ON A CONTINUOUS BASIS; HATCH DETROIT CONDUCTS FUNDRAISING EVENTS AND MAINTAINS A CONTINUOUS AND BONA FIDE PROGRAM FOR SOLICITATION OF FUNDS FROM THE GENERAL PUBLIC. HATCH DETROIT HAS A FULL TIME EXECUTIVE DIRECTOR WHO SPENDS MANY HOURS MAKING VARIOUS ORGANIZATIONS AND PERSONS AWARE OF THE PURPOSES AND GOALS OF THE ORGANIZATION AND SEEKING FUNDING SUPPORT. FURTHER, THE ORGANIZATION HAS AN ACTIVE BOARD OF DIRECTORS COMPRISED OF COMMUNITY LEADERS WHO WORK WITH THE EXECUTIVE DIRECTOR TO SEEK ADDITIONAL FUNDING SOURCES.

HATCH DETROIT ALSO SATISFIES THE ADDITIONAL REQUIREMENTS OF REGS. SECTION 1.170A-9(F)(3)(III). ITS CURRENT PUBLIC SUPPORT PERCENTAGE OF 23.85% IS NEARLY 14 PERCENTAGE POINTS HIGHER THAN THE 10% THRESHOLD REQUIRED BY REGS. SECTION 1.170A-9(F)(3)(I). THIS HIGHER PERCENTAGE SHOULD LESSEN
