What is the organization's primary exempt purpose?
 The Community Food Pantry of Tarrytown and Sleepy Hollow serves community residents who are hungry with monthly grocery distributions. We serve about 275 families each month, including shut-ins. Clients most frequently find us by referral, from the Open Door, school social workers, and religious leaders. Anyone who comes to a distribution is helped. To receive continuing support we request proof of residency in Sleepy Hollow or Tarrytown and photo ID, such as a passport from any country. Our distributions are on the second Thursday of each month, from 8:30 to 10:30 AM and from 6:30 to 8 PM, in addition to special seasonal distributions.
