<p>EVERGREEN TRAINING AND LEADERSHIP DEVELOPMENT PROGRAM In 2013, the Kendeda Fund awarded the Evergreen Cooperative Corporation a two-year grant of \$200,000 (\$100,000/year) to underwrite the development and initial implementation of a comprehensive training and leadership development program for Evergreen worker-owners, cooperative board members and other key stakeholders through the Evergreen system. The purpose of the training program is to prepare Evergreen stakeholders to be effective in their respective cooperatives, engaged participants in the Evergreen system, and inspired leaders in their communities. The training program will do this by engaging all stakeholders in mastering the skills necessary for successfully developing, working in, managing, and governing the Evergreen Cooperative businesses. Impact and Assessment During the first year of the grant period, the following was accomplished: Retained consultants Hilary Abell and Chanell Scott to develop the training framework and curriculum content. Abell has 20+ years of experience in the U.S. cooperative field, including 8 years as executive director of the WAGES cooperative network in the San Francisco Bay Area. She is also an important thought leader in the field and is the author of a report, <i>Worker Cooperatives Pathways to Scale</i>, that was published in June 2014 by The Democracy Collaborative. Scott is a former National Urban Fellow with the Cleveland Foundation with work experience in social enterprise and workforce development. Designed Phase 2 of the Training Program, with a focus on training employees in four curriculum topic areas and providing leadership training for supervisors and crew leaders in all three Evergreen companies. The four curriculum topic areas are Life Skills (starting with communication and self-management), Business Skills (starting with finances and governance), Evergreen Foundations (starting with mission, vision and cooperation), and Job Skills. Used the advice of a prior formed Advisory Group engaged in 2013 to further enhance the Training Program, which included Joselyn DiPetta, a social inclusion and life skills expert with Axialent, Phyllis Robinson, a worker-owner at Equal Exchange who was a popular educator in Central America for many years, Peggy Powell of PHI, thought leader for the coaching supervision model used at CHCA, Steve Dubb and Keane Bhatt of The Democracy Collaborative, and Alex Moss and Linshuang Lu from Praxis Consulting Group. The curriculum on Life Skills and Diversity and Inclusion was further developed, trained 52 employees, representing all three companies, on these topics. Because training is highly interactive, small groups were most effective for learning, and workshops had an average of ten to twelve participants. In all, our consultants trained three groups at ECL, two at GCG and one at E2S, for a total of six three-hour sessions on each topic. Trainees were enthusiastic and eager to continue with the training. They also provided useful feedback to the training team, enabling us to refine and finalize each curriculum after its pilot run. Completed development on the curriculum for Personal and Business Finances. This curriculum was taught in three sessions totaling eight hours. It taught employees financial concepts through the lens of family budgeting and personal financial goal setting, and provide an overview of key business finance topics including profit and loss, how to read a financial statement and the economics of one unit. The financial training used each company's dashboard to deepen employees understanding of Key Performance Indicators. These curriculums were delivered to all three cooperatives totaling 41 workers.</p>

<p>EVERGREEN HOUSING AND DRIVE TO SUCCESS PROGRAMS Evergreen Housing includes assistance with site inspections of the houses, providing the documentation Members need to apply, coordinating the housing and financial training needed to be completed prior to purchasing a house. The program is a joint program between Cleveland Housing Network & Evergreen Cooperative Corporation whereby Members can purchase a home primarily located in Greater University Circle through Cleveland Housing Network, 0% interest, tax abatement, and the homes usually paid off within 5 years. Drive to Success is organized through a Nissan dealership. Each Member leases a new car for 12 months, 3 months no payment, \$200 escrowed via payroll deduction months 4-12, insurance & maintenance paid during that first year. At the end of the year, the Member can use the entire payroll deduction amount to either continue the lease, purchase the auto, or use it towards down payment for another car. Both programs have been very successful. At 12/31/14, 19 worker-owners purchased homes and 3 purchased automobiles through the program.
