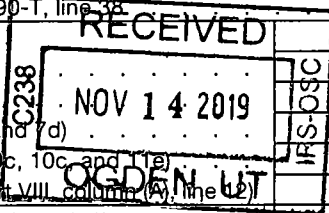

Through individual representation, strategic litigation, community education, research, and administrative and legislative advocacy, PLSE advocates for a more equitable social environment, by allowing those with criminal records to compete for and obtain jobs, credit, training and academic programs, housing, and other opportunities for which they are qualified.

Criminal Records Expungement Project - Employers, landlords, trade schools, academic institutions, professional associations, licensing agencies and others frequently use (often illegally) past criminal record histories to deny otherwise qualified people jobs, housing, education, credit, licensure and other opportunities. This happens even when the interaction with the criminal justice system occurred decades earlier and resulted in no conviction or convictions for merely minor offenses. Pennsylvania law authorizes judges to expunge (delete) all criminal record information that does not result in convictions, and to "seal" (remove from the public record) convictions for certain misdemeanors if there have been no further arrests in over ten years. In FY2019, PLSE provided free legal representation to 1,556 low- and no-income clients who were eligible to have their criminal records expunged or sealed. These clients came to PLSE through 47 intake clinics sponsored by community organizations (like the People's Emergency Center) and held in neighborhoods of need; court programs (like the federal Supervision To Aid Reentry), and other government-related programs. In FY2019, PLSE filed 2,929 expungement petitions, most of which had been drafted by PLSE-trained law students, and all of which were then reviewed, finalized, and prosecuted in the criminal court by PLSE attorneys. Judges granted approximately 99% of the petitions PLSE filed.

4b (Code: 541100) (Expenses \$ 114,429 including grants of \$) (Revenue \$ 131,000)
Pardon Project - With few exceptions, the only way an actual conviction can be removed from a criminal record is through a Governor's pardon - a daunting, often prohibitively expensive process that takes three or more years to complete. PLSE has been working with government leaders to reform the pardon system so that it is not only more accessible to individuals, but a meaningful response to the legacy of mass-incarceration. In FY2019, many major reforms championed by PLSE were implemented, including substantial changes to the application form that made it much shorter, easier to understand, and available for free over the internet, and eliminating unnecessary, burdensome and legally questionable requirements. Partnering with communities of faith and existing non-profits, PLSE has created "Pardon Hubs" in low-income/high arrest neighborhoods and provided cobranded information. Using a "train the trainer" approach, PLSE trains employees and volunteers who are then able to coach eligible individuals in their neighborhoods in how best to complete a pardon application. PLSE created five such "Pardon Hubs" in FY2019 represented 24 individuals (to June 30). PLSE also is producing a series of online YouTube style videos in which the pardon process is explained by who have gone through it, and a mobile-friendly, web-based computer app that helps individuals draft a pardon application. Both of these projects are scheduled to be completed and released in the next fiscal year.

Community Education - There is a growing appreciation of the lifelong harm done by the public availability of permanent criminal records. People change, records don't. In FY2019, PLSE's staff helped explain criminal record histories and their debilitating effects, and what can be done about them, to 1,155 low-income Philadelphians at 55 different community events (in addition to Expungement Project clinics). PLSE also made presentations to employers, community groups, clergy, professional associations, lawyers, business leaders and elected officials building awareness and consensus as to (1) how the social and financial punishments inflicted by criminal history records far exceed those imposed by judicial sentences; (2) how such indirect punishment runs counter to everyone's best interests by restricting the productive lives and talents of its directly-affected citizens and their families, thereby condemning them to intergenerational poverty, and (3) how expungements and pardons can create social capital and are a necessary component of effective neighborhood investment strategies.

Once Executive Director and Board of Directors has signed off on the Form 990 the Chairman of the Board of Directors signs.

Form 990, Part VI, Section B, Line 12c: The organization's Conflict of Interest Policy and Disclosure Statement is distributed in advance of the first meeting of the fiscal year of the Board of Directors and completed disclosures forms are collected at or before the meeting. New members are given the policy at orientation, and their disclosures collected shortly thereafter.

Form 990, Part VI, Section B, Line 15: Staff salaries are set in conformity with the scheduled established for employees of a similar nonprofit agency in Philadelphia area which results from a process of collective bargaining.

Form 990, Part VI, Section C, Line 19: The organizations governing documents, financial statements and Form 990 are available upon requests.

Form 990, Part XII, Line 2a: An independent CPA firm performs a review of the Organization. The independent CPA's review is presented to the Finance Committee of the Board of Directors. Once reviewed and approved by Finance Committee, the review is presented to the Board of Directors for acceptance.
